The Riverbridge Small Cap Growth strategy was established in 1988. It is a diversified growth stock portfolio invested in 40–60 companies of small market capitalization sizes. Due to our long-term investment approach, turnover for the portfolio is low – averaging less than 20% annually. Our time-tested approach has delivered outperformance with less volatility across multiple market cycles.

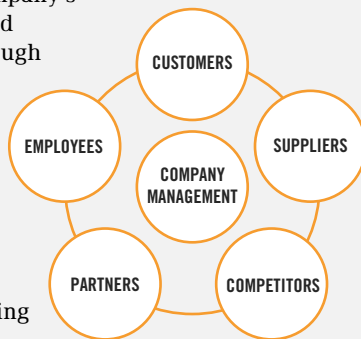
WHO IS THIS STRATEGY FOR?

WHAT MAKES OUR APPROACH DISTINCTIVE?

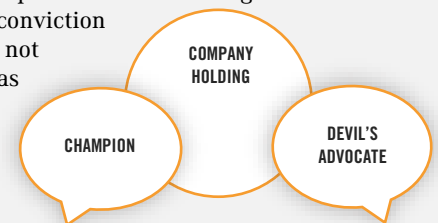
PEER REVIEW PROCESS

- Riverbridge evaluates a company's culture, market position, and customer relationships through extensive interactions with their ecosystem.
- Earnings power is cultivated through the actions a company takes today to position it for greater strength tomorrow. The peer review process gives us a deep understanding of those actions.



DIFFERENTIATED DECISION-MAKING STRUCTURE

- Each member of the investment team is empowered to **champion** a company they believe makes the portfolio stronger.
- Every holding is then assigned a **devil's advocate**; for positions to become larger than their initial 1.5% weighting, they must have devil's advocate support. Through this process, holdings become more influential in the portfolio due to strong execution and increasing conviction in the business, not confirmation bias or bets on stock catalysts.

FUNDAMENTALLY DIVERSIFIED

We focus on earnings correlation risk to achieve proper diversification. No more than 20 percent of the portfolio can be exposed to a catalyst beyond management control. This has led to a strategy with lower volatility than its benchmark since inception.

PERFORMANCE PATTERNS

Riverbridge's strategies have generated consistent performance patterns over time.

- The strategy's performance objective is to outperform its benchmark over the course of a full market cycle.
- The strategy tends to perform best relative to the benchmark during challenging economic environments. Riverbridge's focus on self-financed businesses with high degrees of recurring revenue and a strategic market position tends to lead to fundamental results which are relatively less sensitive to downturns in the economy.
- The strategy is likely to lag during periods of market speculation and economic acceleration. Riverbridge does not invest in the riskier, more cyclical companies that are often in favor during such periods, instead preferring companies with steady unit growth regardless of the economic environment.

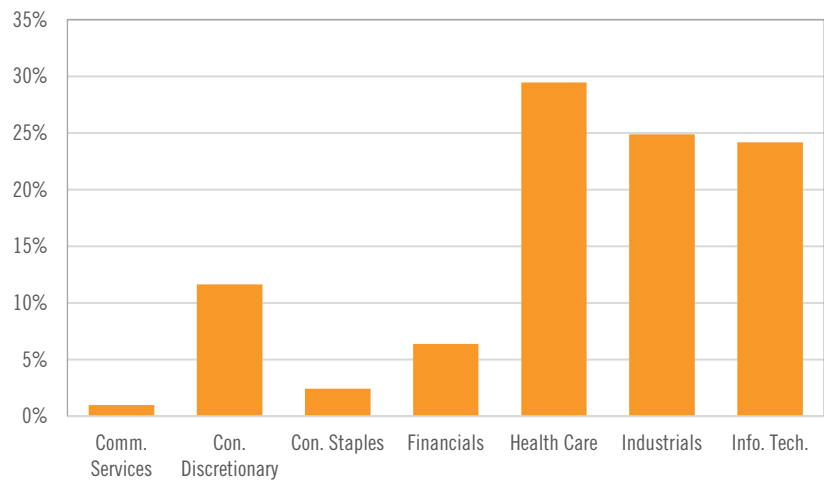
